TOWNSHIP BOUNDARIES<br>Red Bluff Weekly Sentential, November 21, 1874<br>Transcribed by G. Alice Jackson

Below we give the Township boundaries, also the boundaries of the several voting Precincts. In each Township, as fixed by the Board of Supervisors at their last regular session:

RED BLUFF Township shall be bounded and described as follows: Commencing at a point at the south point of the Grant known as Dye's Grant on the Sacramento river at the mouth of Reo de Los Berrendos; thence north east to the eastern point of said Grant; thence north west to a point at which said Grant crosses the east line of Township 26, north range, 2 west; thence north about 11 miles to the northeast corner of section 13 of Township 38, north range, 2 west; thence west $81 / 2$ miles to the Sacramento river; thence west $91 / 2$ miles to the north west corner of section 18, Township 28, north range, 4 west; thence south 4 miles to the southwest corner of Township 28, north range, 4 west; thence west 6 miles to the north west corner of Township 27, north range, 5 west; thence west 1 mile; thence south 6 miles to a point 1 mile west of the south west corner of Township 27, north range, 5 west; thence west to the county line; thence south 6 miles to the Township line between Township 25 and 26; thence east to the south east corner of Township 26, north range, 4 west; thence north about 1 mile to the Rancho de Los Flores or Chard's Grant; thence northwest to the western point of said Grant; thence northeast on the line between said Grant and Ide’s Grant to the Sacramento river; thence down said river to the place of beginning.

That portion of Red Bluff Township which is east of the Sacramento river shall be Antelope Precinct, and that portion west of the Sacramento river shall be Red Bluff Precinct.

TEHAMA TOWNSHIP shall be bounded and described as follows: Commencing at a point where the South line of Township 23 north intersects the Sacramento river: thence west about 10 miles to the south west corner of section 33, Township 23, north range, 3 west; thence north 6 miles to the north west corner of section, 4 Township 23, north range, 3 west; thence west 2 miles to the southwest corner of Township 24, north range, 3 west; thence north 9 miles to the northwest corner of section 19, Township 25, north range, 8 west; thence west 10 miles to the south west corner of section 16 , Township 25, north range 5 west; thence north 3 miles to the north west corner of section 4, Township 25 , north range, 5 west; thence east 10 miles to the south east corner of Township 26, north range, 4 west; thence north 1 mile to the Chard Grant; thence north west to the western corner of said Grant; thence north east about 8 miles along said Grant line to Sacramento river; thence down said river about 3 miles to where the southern line of Dye's Grant Intersects the Sacramento river; thence north east along the southern line of said Grant to the eastern line thereof; thence north west about $1 / 2$ mile to the western boundary line of Township 26 , north range, 1 west; thence north about $1 / 2$ mile to the north west corner of Township 26, north range, 1 west; thence east to the county line; thence south to the southeast corner of the county; thence west along the county line to the Sacramento river; thence down the river to the place of beginning.

Said Township to be divided into 3 voting precints, viz: Tehama, Lassen and Inghram, which shall be bounded and described as follows, to wit.

Lassen Precinct is composed of all that portion of Tehama Township east of the Sacramento river and south of, and east and west along the southern line of section 24 Township 25, north range, 2 west.

Inghram Precinct is composed of all that portion of Tehama Township west of the Sacramento river and south of the southern line of Township 24 north, excepting that portion of Thomes Grant south of said line.

Tehama Precinct shall be composed of all that portion of Tehama Township not included in the boundaries of Lassen and Inghram's Precincts.

PASKENTA TOWNSHIP shall be bounded and described as follow, viz:
Commencing at the north east corner of section 24, Township 25, north range, 4 west; thence west 10 miles to the north west corner of section 21, Township 25 , north range, 5 west; thence north 3 miles to the north east corner of section 5 , Township 25 , north range 5 west; thence west to the county line; thence south to the south west corner of the county; thence east to the south east corner of section 32, Township 23, north range, 3 west; thence north 6 miles to the north east corner of section 5, Township 25 , north range 3 west; thence west 2 miles to the south east corner of Township 24, north range, 4 west; thence north 9 miles to the place of beginning.

Said Township is hereby divided into three (3) Precincts namely Paskenta, Henley's and Butte Mountain, and the several boundaries are as follows:

Paskenta Precinct, commencing at the north east corner of section 5, Township 25 , north range, 5 west; thence west to the county line; thence south to the south west corner of the county; thence east to the southeast corner of section 32, Township 23, north range 5 west; thence north 18 miles to place of beginning.

Henley Precinct, Commencing at the north east corner of section 24, Township 25 , north range, 4 west; thence west 10 miles to the north west corner of section 21 , Township 25 north range, 5 west; thence south 9 miles to the ssouth-west corner of section 33 , Township 24 , north range, 5 west; thence east 10 miles to the south east corner of Township 24, north range, 4 west; thence north 9 miles to place of beginning. Butte Mountain Precinct. Commencing at the north east corner of section 5 Township 23, north range, 3 west; thence west 12 miles to the north west corner of section 4 , Township 23, north range, 5 west; thence south 6 miles to the south west corner of section 33, Township 23, north range, 5 west; thence east 12 miles to the south east corner of section 32, Township 23, north range, 3 west; thence north 6 miles to the place of beginning.
